Sub: Outcome of Postal Ballot & E-voting

Pursuant to provisions of section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015, the approval of shareholders was sought by way of postal ballot for:

1. Alteration in the Article of Association of the Company.

The Company had availed the e-voting facility offered by National Securities Depository Limited (NSDL) for conducting e-voting by shareholders of the company. The Company has also provided voting by physical ballot form along with a self- addressed postage pre-paid Business Reply Envelope to the shareholders of the Company. Further, the shareholders holding shares as on the "cut-off" date i.e. 24th November, 2017 were entitled to vote on the proposed resolutions as set out at item no 1 in the Postal Ballot Notice dated 27th November, 2017.

Accordingly the e-voting period remained open from 09.00 a.m. on 30th November, 2017 upto 5:00 p.m. on 29th December, 2017 and the NSDL e-voting platform was blocked thereafter. Votes cast through physical ballot forms received upto 5:00 p.m. on 29th December, 2017 were considered.

The Scrutinizer conducted the voting process in a fair and transparent manner and ascertaining the requisite majority for the said voting.

The resolution was passed with requisite majority by the members of the Company as special resolutions.

The result of the Postal Ballot & e-voting as per prescribed format of the SEBI (LODR) Regulations, 2015 is attached herewith along with the report of Scrutinizer thereon.
