In February, 2015 Company migrated to Main Board of BSE Limited from SME Platform being India's 1st Company to migrate from BSE SME to BSE Main Board. Further in the month of May, 2016, Company started its Corporate Office in Mumbai, Maharashtra. SRGHFL has outstanding AUM of Rs. 200.3 Crore as on March 31, 2018.
